Staff positions focus on day-to-day operations including but not limited to data, analytics, health information, client programs, provider and referral partnerships, per-diem volunteer management, program execution and operations, budgets and marketing.</p> <p>Staff is the front of the line members facing client and office adversities alongside them on a daily to weekly basis.</p> <p>Commitment: Varies</p> <p>In-Person or Remote</p>	<p>Per-Diem Volunteers (PDV) are elected by any member or department of the organization. PDVs are committed to the organization and its mission, though only on an at-will or at-need basis determined by either the person him/herself or the organization.</p> <p>PDVs may be client facing, community facing, assistants to the Board for fundraising events, or other needs as they arise.</p> <p>Commitment: At-Will</p> <p>In-Person or Remote</p>
